**P.C. :**

1. An ad-interim order came to be passed on 21<sup>st</sup> December, 2016 and that order has been extended from time to time since Notice of Motion is still pending. The last extension was granted on 22<sup>nd</sup> November, 2019.

Notice of Motion, however, could not be heard as practically as the whole year 2020 has been lost because of this covid pandemic. Therefore until hearing of Notice of Motion, ad-interim order dated 21<sup>st</sup> December, 2016 shall continue.

2. As regards COMIP No.120 of 2019 Mr. Nadkarni seeks leave to withdraw the suit against Defendant No.1 – British Brewing Company Pvt. Ltd. & Ors. The suit against Defendant No.1 – British Brewing Company Pvt. Ltd. & Ors. is dismissed as withdrawn with no order as to costs.

Mr.Nadkarni states that pursuant to the interim order Defendant No.1 has deposited with Prothonotary and Senior Master, High Court, Bombay a sum of Rs.1,50,000/- and prays for return of that amount with accumulated interest, if any. Advocate Amogh Singh has no objection. Therefore, Prothonotary and Senior Master, High Court, Bombay to return the amount of Rs.1,50,000/- together with accumulated interest, if any, to Defendant No.1.

3. Mr. Nadkarni prays that a fix date to be given to hear Notice of Motion. As the situation stands, it is really difficult to give a peremptory date. Once, the court starts functioning normally, liberty is given to the parties to apply to the court for fixing peremptory date to hear these Notices of Motion.

4. Whichever party has not filed the reply to Notice of Motion may file and serve copy within two weeks.
  
5. Rejoinder, if any, to be filed within two weeks thereafter.
