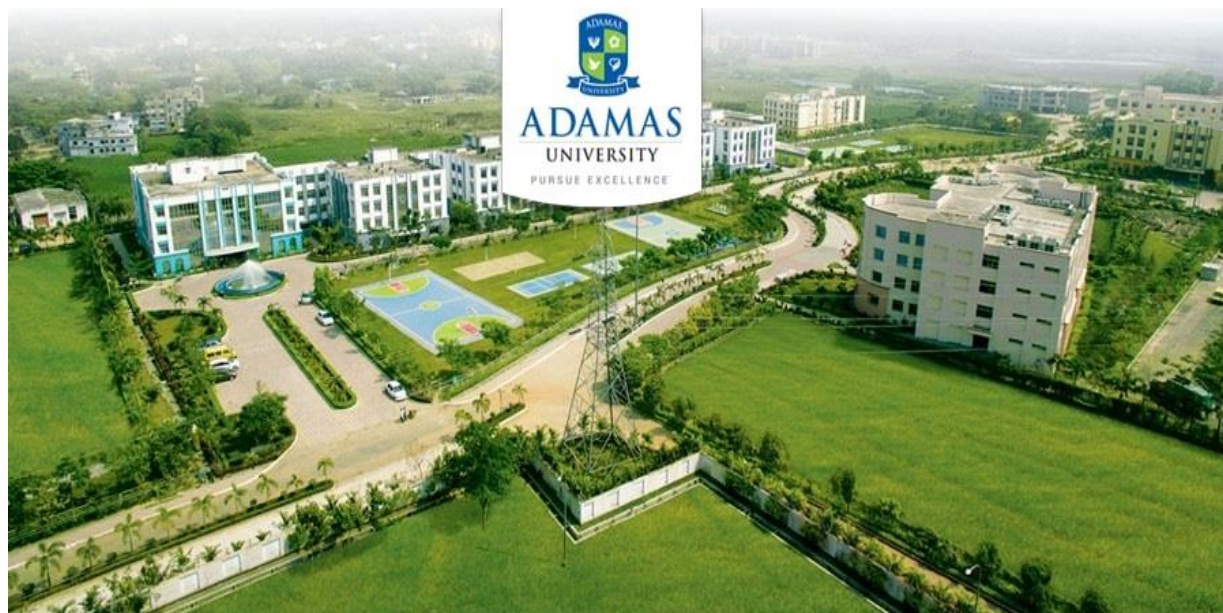

3. About the Adamas University

Adamas University has been established by Sachis Kiran Roy Memorial Trust (**SKRMT**) (under the West Bengal Act IV of 2014) passed by the West Bengal Legislature and approved by the Governor. The

provisions of the **Adamas University Act, 2014**, have come into effect from 11th April 2014, through a gazette notification issued by the Govt. of West Bengal on the same day.

The parent organization, the **RICE Group** will also continue to contribute to shaping the destiny of the youth of West Bengal pursuing their studies in Adamas University.



Adamas University, with a sprawling green campus extending over 120 acres, nestled in Barasat (13 kms from the Subash Chandra Bose International Airport Kolkata), and in its 9th year of operations, aspires to impart the finest quality education to the young minds of West Bengal, with an already established high quality research facility and a powerful team of teachers.

Adamas Foundation is focused on integrated development of the areas around the University, which falls in the Barasat Sadar subdivision.

The focus of the foundation is to improve Human Development Index (HDI) of the area, by focusing on health and healthcare, education and improved standards of living. The focus is on having a balanced development which is a combination of multiple interventions in education (Anganwadis and primary), healthcare (primary), access (infrastructure, water and legal help), readiness (skill development) and related areas.

The 7th Convocation of Adamas University was held on 9th February, 2024 in the presence Mr. Kailash Satyarthi, Nobel Peace Laureate as Chief Guest.

Mr. Kailash Satyarthi, a prominent social reformer and Nobel Peace Laureate, stands out as an exceptional leader and an unwavering advocate for the marginalized and voiceless. In 2014, he was honoured with the Nobel Peace Prize for his tireless crusade against the oppression of children and youth, and his unwavering commitment to ensuring every child's right to education. With Satyarthi Movement for Global Compassion, he exemplifies a life guided by compassion, setting an unmatched standard in the field of social reforms. Through his courageous and persistent advocacy, he has played a pivotal role in shaping ground-breaking legislations worldwide, with the aim of eradicating violence against the powerless. His remarkable efforts have left an indelible mark on the path to a more equitable and just society.





Through his organization, Bachpan Bachao Andolan, Mr. Satyarthi has liberated more than 100,000 children from child labour, slavery, trafficking and other forms of exploitation and developed a successful model for their education, rehabilitation and reintegration into the mainstream society. The Global March Against Child Labor, which he led, galvanized support in 103 countries resulting in the adoption of ILO Convention 182 on the Worst Forms of Child Labor, which went on to become the only universally ratified convention in the history of the ILO.

He is also the founding president of the Global Campaign for Education, an exemplar civil society movement working to end the global education crisis. He successfully spearheaded a countrywide movement to make education a Constitutional Provision which subsequently paved the way for the Right to Free and Compulsory Education in India in 2009. Mr Satyarthi is credited for establishing GoodWeave International (previously known as Rugmark), a first of its kind certification and social labelling mechanism for child labour free carpets in South Asia. He has worked to advance ethical business practices, to help businesses liberate their supply chains from child labour.

7. Statutory Bodies and Councils of Adamas University

7 (i) Governing Board:

The powers and functions of Governing Board

- a) to approve of the recommendations of the Academic Council regarding new course to be introduced;
- b) to finalize the fees structure of different courses of the University;
- c) to approve the proposals recommended by the Academic Council regarding creation of any new School of Study, Centre of Study or any entity for imparting education;
- d) to approve the proposals recommended by the Academic Council regarding the terms and conditions of appointment of Visiting Professors, Emeritus Professors, Consultants and Scholars;
- e) to maintain a Register of Donors of the University;
- f) to approve and issue directions to the officers of the University in regard to the budget, annual accounts and audit reports presented in its meetings;
- g) to enter into, modify, carry out and cancel contracts on behalf of the University;
- h) any other power or function as may be entrusted to it by the Statutes, Ordinances, Regulations or Rules of the University.

Subject to the provisions of the Act, the Statutes and the Ordinances, the Governing Board shall, in addition to the powers vested in it by and under the Statutes, have the following powers, namely, -

- a) to create teaching and other academic posts and to define the functions and conditions of service of the professors, Associate Professor, Assistant Professor, other teachers and the academic staff employed by the University after taking into consideration the recommendations of the Academic Council;
 - b) to prescribe qualifications and other conditions of eligibility for teachers and other academic staff after taking into account the recommendations of the Academic Council;
 - c) to make appointments of such professors, Associate Professor, Assistant Professor, other teachers and such academic staff as may be necessary, on the recommendations of the selection committees constituted for the purpose;
 - d) to make appointments to temporary vacancies of any academic staff;
-

- e)** to specify the manner of appointment to temporary vacancies of the academic staff;
 - f)** to provide for the appointment of visiting professors, artists, writers and other professionals/experts and determine the terms and conditions of such appointment;
 - g)** to manage and regulate the finances, accounts, investments and properties of the University and all other affairs of the University and to appoint such agents as may be considered fit by it;
 - h)** to invest any money belonging to the University, including any unapplied income, in such stocks, funds, shares or securities as it thinks fit or in the purchase of immovable property in India with the like power of varying such investment from time to time.
 - i)** to create administrative and other necessary posts and to specify the manner of appointment and conditions of services thereto;
 - j)** to regulate and enforce discipline amongst the employees in accordance with the Statutes and the Ordinances;
 - k)** to transfer or accept transfers of any immovable or movable property on behalf of the University;
 - l)** to entertain, adjudicate upon or redress the grievances of the employees and the students of the University who may, for any reason, feel aggrieved;
 - m)** to fix the remuneration payable to examiners and invigilators and traveling and other allowances payable;
 - n)** to select a common seal for the University and to provide for the use of such seal;
 - o)** to delegate any of its powers to the Pro Chancellor, Vice-Chancellor, the Pro Vice- Chancellors, the Registrars, the Chief Finance Officer, the Controller of Examinations or any other Officer, employee or authority of the University or to a Committee appointed by it;
 - p)** to institute fellowships, scholarships, studentships;
 - q)** to enter into partnership with industry and non-governmental agencies for the advancement of knowledge and generate funds out of the profit of such partnership; and
 - r)** to provide building, premises, furniture and apparatus and other means needed for carrying out the work of the University

7(ii) Academic Council

The power and functions of Academic Council

- f) to consider and recommend to the Governing Board, proposals submitted by any Faculty Council or Research Board in respect of courses of study and research programmes, respectively;
- g) to consider and approve or reject the recommendation of the Research Board regarding any thesis submitted by a candidate for

the degree of Doctor of Philosophy under any Faculty Council of the University;

- h)** to make recommendation to the Governing Board with regard to -
 - i.** the Degrees, Diplomas and Certificates to be awarded by the University and the conditions thereof;
 - ii.** the creation of posts required for teaching in the University, or abolition thereof, if required;
 - iii.** the classification of the posts referred to in sub-clause (2) and the duties attached thereto as per University Grants Commission and other Regulatory Body norms;
- i)** to recognize Degrees, Diplomas or Certificates of other Universities or Institutions and to determine their corresponding status;
- j)** to recommend institution of stipends, scholarships, medals and prizes and to fix, subject to any conditions prescribed by the Governing Board, the tenure, mode and prerequisites of award of fellowships, scholarships, medals and other prizes and to recommend award of the same;
- k)** to exercise general supervision over the conduct of the University examinations;
- l)** to perform, in relation to academic matters, all such functions and to do all such acts as may be necessary for the proper carrying out of the provisions of the Act, the Statutes, the Ordinances, the Regulations of the University.
- m)** to exercise such other powers and perform such other duties as may be conferred or imposed in it by the Act, the Statutes, the Ordinance and the Regulations.

Ph.D. Program

Ph.D. Regulations of Adamas University have been framed in accordance to UGC Regulations 2016 and subsequent amendments. R&D unit of Adamas University, has taken steps to streamline the Ph.D. program by implementing the following initiatives:

1. Issuing Enrolment certificates
2. Issuing Registration certificates
3. Forming and notifying DC committees for all enrolled students
4. Conducting DC committee meetings twice in an academic year and maintaining reports of the same
5. Preparing Coursework Completion Certificates
6. Issuing Supervisor Allotment Letters
7. Conducting regular meetings of URC
8. Regularising Coursework program in line with UGC requirement

There are at present 201 students registered for Ph.D. under various schools. There are at present 85 Ph.D. supervisors registered as Ph.D. Guides under various schools.

Adamas University R&D Policy

Adamas University wishes to establish itself as one of the frontline research institutions in India. In order to fulfil its mission, research promotion policies with various schemes and incentives are adopted and implemented. The primary objectives of the Research Policy are to:

- i) Publish quality research articles in reputed journals with global citations
- ii) Publishing patents with the aim of monetisation
- iii) Securing extramural funding and establishing state-of-the-art laboratories and research facilities
- iv) Providing consultancy services to industry and other organisations
- v) Establishing central instrumentation facility
- vi) Recognising faculty members for research initiatives through incentives and awards
- vii) Collaborating with Govt./NGOs/industries
- viii) Establishing Centres of Excellence in focus areas
- ix) Providing support to staff members for attending conferences, seminars, workshops and others.

Research Advisory Board (RAB) comprising internal and external members from industry and academia has been formed to provide

direction in implementing the above objectives. Internal Quality Enhancement and Excellence in Research (IQEER) Committee under the Chairmanship of the Hon'ble Vice-Chancellor, with the Dean (R&D) being its Member Secretary. The committee shall meet on a regular basis to take decisions and submit its recommendations to Hon'able Chancellor for internal seed fund/grant-related sanctions.

In addition to these, the University has initiated the Annual Research Excellence Awards to faculty members for outstanding and innovative research.

To give effect to these, the **Adamas University (Research, Innovation and Extension) Regulations, 2019** was endorsed and adopted by the Academic Council.
