### MEDICAL EDUCATION COMMITTEE (MEC)

#### **Applications are invited for Official Recommendation of Candidates to Minority Network Category for M.B.B.S. and Other Allied Medical Courses conducted by CMC, Vellore.**

This Recommendation program is envisaged to obtain Admissions for prospective Christian (Brethren) Students in the respective Medical Fields, which in turn will enable them to serve the people through medical professions in our Hospitals and dedicate their lives for the service and witness of the Lord. On successful completion of their Course, for which they are recommended, Candidates are required to serve in any of our Hospitals for a period of 2 (Two) years.

#### **Given below are the Eligibility Criteria:**

- Members or Children of Members of a Christian Assembly (Brethren) for a minimum period of 10 (Ten) years.
- Passed 10 +2 or equivalent examination or appearing for Final examination.
- Recommended by the Elders of the respective Assembly, with whom, they or their parents are in fellowship.
- All **MBBS applicants** must appear for **NEET-UG 2026** and **apply to the Tamil Nadu Selection Committee for the counselling.**
- Kindly note, for candidates applying for BOT/BPT courses: As per the National Commission for Allied and Healthcare Professions notification dated 09-01-2026 and Tamil Nadu State Allied and Healthcare Council notification dated 03-12-2025, admission to the BOT and BPT course shall be based on NEET merit/marks. Therefore, candidates are advised to appear for NEET UG 2026 examination to be eligible for admission to the Bachelor of Physiotherapy (BPT) and Bachelor of Occupational Therapy (BOT) Courses at Christian Medical College, Vellore. Candidates are also advised to appear for the Entrance Test conducted by Christian Medical College, Vellore, in case NEET is not implemented this year, and for selection to the other allied health courses in Christian Medical College Vellore.
- BSc Nursing Chittoor campus applicants must appear for APNCET 2026

#### **Process for Applying:**

Kindly visit CMC, Vellore website: <http://admissions.cmcvellore.ac.in/> and apply for the relevant Undergraduate Course to Christian Medical College, Vellore with payment of relevant fees and obtain the **Registration Number**. This **Registration Number\*\*** will be cross-referred in all application documents of CMC, Vellore as well as MEC, Bangalore. When communicating with CMC, Vellore, please quote the name of the Recommending Body Correctly as **“CHRISTIAN ASSEMBLIES IN INDIA”**.

**\*\* please note on submission of application in CMC Vellore website, the final Form downloaded, carries a “TEMPORARY LOGIN ID”. Subsequently, you will receive an official communication from CMC Vellore by email with the finalized CMC APPLICATION FORM, which contains the 7-digit OFFICIAL APPLICATION NUMBER. This number need to be entered in our internal registration form in Stewards Association in India website, as guided in the next paragraph.**

- After completing above process, kindly visit our website: website: <https://stewards-india.com/cm-c-ug-admission-2026/> and register the candidate with the relevant information and the questionnaire filled by the candidate (**Incomplete / Illegible forms are liable for rejection**) and hit the submit button. On submission, an email will be generated and the same will be sent to your registered email address with further instructions along with a PDF copy of the completed **MEC Application Form**.

Kindly follow the instructions in your email and complete the process. **Ensure that the Certification Form along with scanned copies of the following documents** may be sent urgently by email to: [stewards.assn@gmail.com](mailto:stewards.assn@gmail.com) and Originals by **Courier/Speed Post** on or before **6<sup>th</sup> April 2026**.

2. **A passport size photograph** of the candidate, with name of the candidate mentioned on the reverse side of the photograph attested with the signature of your Parent / Legal Guardian or an Elder of your Assembly / Church.
3. **Evidence of payment MEC Registration Fees of Rs. 750/-** which can be paid by online/ NEFT to Stewards Association in India, A/c No. 0009053000022770, South Indian Bank, Cantonment, Branch, Bangalore, IFSC Code. SIBL0000009. **OR** to the QR code / UPI ID: qr.stewards@sib
4. Upon receipt of the completed **MEC Application Form**, and after the Selection Committee Meeting, we will be sending the candidate by **email** the **OFFICIAL CERTIFICATION FORM of CMC, Vellore**, which needs to be **signed in the relevant places by the Candidate and the Parent/Guardian**. The same needs to be scanned and returned to us **at the earliest by email**, and the said email and the Original Documents may be sent by **Courier/Speed Post**, so that the same may reach this Office **on or before 25<sup>th</sup> April 2026, positively**.
